CLASS A COMMON SHARES – MEMBERSHIP SHARES

- Maximum number of shares 1,000
- Par value of shares \$100
- No member can hold more than one (1) Class A Common Share
- Class A Common Shareholders shall be entitled to vote at all meetings of the members, with one vote appertaining to each such Share.

CLASS B PREFERRED SHARES

- Maximum number of shares Unlimited
- Par value of shares \$1,000
- No member can hold ten (10) percent or more of Class B Preferred Shares in any one solar installation project
- The mutual intent of the Co-operative and its members is that all funds received by the Co-operative from its sale of Class B Preferred Shares shall be used to purchase, maintain, operate or replace solar energy infrastructure.

Maximum – 11

- 5.0 Objects or purposes that the co-operative is intended to fulfill
 - a) Catalyst for growth of solar power generation industry in Saskatchewan
 - b) Financially, environmentally and socially sustainable
 - c) Committed membership base
 - d) Provide public education, awareness and advocacy on benefits of solar energy production
 - e) Connect suppliers, installers, distributors and consumers
 - f) Provide cost effective opportunities for solar installation, both large and small
 - g) Provide investment opportunities
 - h) Create employment opportunities
 - i) Provide the best services and products to optimize solar production
 - j) Reduce reliance on fossil fuels and reduce greenhouse gas emissions

7.0 Other provisions, if any

Without restricting its powers and legal capacity, the Co-operative shall have the power to enter into contracts or arrangements with its members or patrons, as permitted in Section 126 of *The Co-operatives Act, 1996* relating to the production and sale of electricity from solar energy including:

- 1. Dealings with members regarding any one or more of the acquisition, installation, repair and maintenance of equipment and facilities required to produce electricity from solar energy (the "Equipment");
- 2. Dealings with members regarding ownership of the productive capacity of the Equipment, or to the provision to the Co-operative of electricity generated using the Equipment;
- 3. Dealings with members or patrons regarding the sale by the Co-operative of electricity generated using the Equipment; and
- 4. Dealings with its members or patrons incidental to its production or sale of electricity from solar energy.
